

**RE:** NOTIFICATIONS OF ASBESTOS INSPECTIONS

**DATE:** AUGUST 28, 2016

IN COMPLIANCE WITH THE US ENVIRONMENTAL PROTECTION AGENCY (EPA) ASBESTOS HAZARD EMERGENCY RESPONSE ACT (AHERA), IN THE FALL OF 1988, WE PERFORMED INSPECTIONS OF EACH OF OUR SCHOOL BUILDINGS FOR ASBESTOS-CONTAINING BUILDING MATERIALS. THE INSPECTION FINDINGS AND ASBESTOS MANAGEMENT PLANS HAVE BEEN ON FILE IN EACH SCHOOL ADMINISTRATIVE OFFICE SINCE THAT TIME.

THE EPA REQUIRES US TO PERFORM PERIODIC SURVEILLANCES OF THE ASBESTOS MATERIALS EVERY 6 MONTHS. ASBETOS INSPECTORS PERFORM THESE SURVEILLANCES AND AN ACCREDITED MANAGEMENT PLANNER REVIEWS THE RESULTS OF THE SURVEILLANCES AND RECOMMENDS ACTIONS WE SHOULD TAKE TO SAFELY MANAGE EACH ASBESTOS MATERIAL IN OUR BUILDINGS.

NO SIGNIFICANT CHANGES IN THE ASBESTOS MATERIALS CONDITION WERE NOTED DURING THE 2016-2017 SURVEILLANCE OF LEE COUNTY SCHOOLS.

ALL ASBESTOS MATERIALS IN OUR SCHOOLS ARE IN SATISFACTORY CONDITION AND WE PLAN TO CONTINUE TO MANAGE THEM IN PLACE, AS RECOMMENDED BY THE ACCREDITED MANAGEMENT PLANNER.

THE RESULTS OF THE SURVEILLANCE ARE ON FILE IN THE MANAGEMENT PLAN IN THE SCHOOL'S ADMINISTRATIVE OFFICE. EVERYONE IS WELCOME TO VIEW THESE AN YTIME DURING NORMAL SCHOOL HOURS (MONDAY - FRIDAY, 8:30 A.M. - 3:00 P.M.).
